

# AI Prompt Cheat Sheet

## MODES AND ROLES

**Intern:** Find research on [topic]

**Brainstorming:** Generate ideas on [topic]

**Assistant:** Edit and fix this text: [text]

**Teacher:** Explain this [concept]

**Reporter:** Generate a summary of news on [company]

**Typist:** Draft an email to [person] about [subject]

**Marketer:** Prepare a presentation on [subject]

**Scheduler:** Create a schedule with [dates, times, or tasks]

**Mentor:** Generate a script to call [person] at [company] that [services or products]

**Researcher:** Identify the top [number, i.e., 20] companies in [industry] by [category]

**Editor:** Rewrite this text and [objective]

**Proofreader:** Review writing and fix mistakes. Make suggestions for improvement.

## TONES

**Prompt:** Write using [x] tone

## ROLE + TASK + FORMAT

To create your prompts, think about your modes and roles. One prompt will **not** give you the final result. It will take an initial prompt and re-prompts to get a good result.

**Role:** Intern

**Task:** Research

**Format:** Descriptive

It is important that you verify any statistics and double check whatever AI results you receive. It is also recommended that you request several variations to get a result that has the right tone, phrasing, and information. Double check spelling as AI libraries will provide sometimes European spellings opposed to American spellings (colour versus color).

# AI Prompt Tips and Tricks

## PROMPT STRUCTURE

- Give clear and precise instructions.
- The more details you can provide in the prompt, the better results you will get.
- It can be helpful to include target audience or objective of the writing or review.

## RE-PROMPT GUIDANCE

- Communicate mistakes when easily identifiable.
- Point out any instructions in the original prompt that were missed.
- Tell AI what you like and do not like.
- Be aware of using words that can be confusing.
- Be as specific as possible.
- Break up longer text pieces into sections to easier management.
- Try providing step-by-step instructions.
- Rephrase your original request.
- Explicitly define expected results, i.e., three paragraphs, 280 characters, 40 words.
- Ask for references for sources used; provide citation requirements, i.e., APA, MLA.
- Request multiple versions or a list of options to choose from.

## TRIAL AND ERROR

- Crafting consistent prompts takes practice.
- Each AI model is different, so you will get different results from different models.
- You are ultimately responsible for what you choose to use.
